

TRANSITION TO NEW RESOURCE CENTERS

The transition from the old to the new model began in 2016 with the legislative appropriation for initial resource center model funding, in-depth shelter bed needs analysis and statewide implementation of diversion for families. The transition process will continue through the opening of the three new resource center scheduled for June 2019. The final six months of the transition will be guided by a transition team, including issue-specific subcommittees. See below for a breakdown of the transition team and timeline.
